## END USER LICENSE AGREEMENT for ABFO Images

IMPORTANT--READ CAREFULLY: This ABFO End User License Agreement ("END USER LICENSE") is a legal agreement between you and the American Board of Forensic Odontology, Inc. (ABFO) for the ABFO Images, which includes digital media and printed materials (if any) associated therewith that contain the intellectual property of ABFO that you may now or hereafter obtain. By installing, copying or otherwise using the ABFO IMAGES, you agree to be bound by the terms of this END USER LICENSE. If you do not agree to the terms of this END USER LICENSE, you are not authorized to use the ABFO IMAGES and, if you paid money for the ABFO IMAGES, you should return it to the vendor you bought it from for a refund. Do not return the ABFO IMAGES to ABFO unless you bought it directly from ABFO.
